Call for Papers: The Physiology of Obesity

Editor-in-Chief Dr. Barbara E. Goodman and the editorial team of Advances invite submission of manuscripts on the topic "The Physiology of Obesity." This Call for Papers is a unique cross-journal collaboration among the journals of the American Physiological Society.

Advances is requesting submissions for a collection of teaching about Lifestyle Medicine concepts (obesity, nutrition, exercise, metabolism) to a specific learner population (K-12 outreach, undergraduate, graduate, professional, lay public). A collection of "how to do it" papers similar to the Advances article type Illuminations would be appropriate. The physiology of obesity can be addressed as a risk factor or as a chronic disease. Accompanying laboratory activities would also be welcome.

The evolving interest in the physiology of obesity is reviewed in an Editorial in the American Journal of Physiology-Lung Cellular and Molecular Physiology that was written by the Editors-in-Chief of all participating journals and that serves to launch this Call for Papers:

Articles published from this Call for Papers will be highlighted at the time of publication in a special joint collection with participating APS journals. The article collection will also include specially commissioned review articles on the topic.
